RULES OF ENTRY

- Arrival from 1pm Thursday 15th of August 2024. People trying to arrive earlier than this will be asked to park in the public car park (i.e. holding area) with no entry to the show field. **NO EXCEPTIONS!**
- You must arrive before 10pm, any arrivals after this time will be asked to park in the public car park. (i.e. holding area)
- We expect you to trade from 10am Saturday and Sunday until 4:30pm on Saturday and 4pm on Sunday.
- All vehicles and accommodation must be removed from the event no later than 10:30am on Monday 19th of August 2024
- Trader passes entitle you to entry for **one** of the following; caravan and vehicle, tent/vehicle and trailer, motorhome and trailer. Along with 2 adults and 3 children (under 16). Extra camping space and people will be charged at the public rate.
- It is your responsibility to ensure that you, your trade stand or any of your property does not cause any damage, safety concern or injury.
- BBQ's are only permitted if raised off the ground and used in a controlled manner.
- No campfires or fire pits permitted.
- All generators must be turned off no later than 10pm
- Please remember this event takes place on a field, it is uneven and you may need chocks to level your accommodation up.
- The Road Traffic Act applies on site at all times.
- There will be a 5mph speed limit during the event. (Movement of vehicles is prohibited without the presence of a steward during show hours, 10am - 4:30pm.)
- No drones are allowed on or above the site without prior consent.
- Dog owners are legally liable for the dogs, all faeces must be picked up and discarded in a bin, **ALL** dogs are to be kept on leads at all times. (We know everyone loves their dog as if they were children, god knows we do, and we say she wouldn't hurt a fly. But unfortunately you never know, so for the purposes of the show, please keep them on a lead.)
- Vehicles are not permitted to carry passengers unless specifically designed to.
- In the event of an emergency please contact a member of staff or safety crew (fire, first aid or security.)
- Water and elsan points are marked throughout the site. (Please note water must be boiled before drinking and drunk at your discretion).
- Please discard all rubbish in the bins provided.
- No glass bottles allowed on site.
